

APPEARANCE RELEASE

I, _____ (“Participant”) (and if such Participant is under 18 years of age, then also the parent or legal guardian of such individual) sign this release (“Release”) in consideration for appearing in the production related to the marketing and promotion of the Philadelphia Union and its affiliates currently entitled “Chester Union”(the_“Program”) produced by Pennsylvania Professional Soccer LLC and/or Soccer United Marketing, LLC and Major League Soccer, L.L.C. (collectively, the “Producer”).

Producer its successors, assignees, licensees and affiliates have the irrevocable and perpetual right, but not the obligation, to use, in all media through which Producer may distribute its content to end users, as Producer desires, all still and motion picturesand recordings Producer makes of me or my voice during my appearance, including the right to use my name, face, voice, likeness and biographical information in the Program and other Producer programming as well as in connection with advertisingand promotion of the Program or other Producer programming.

I acknowledge that I shall not be entitled to any compensation for my appearance or subsequent use of my appearance pursuant to Section 2 above.

I will refrain from any offensive or distasteful remarks or conduct in the rendering of my appearance hereunder and will conduct myself in a courteous and professional manner at all times during the rendering of the appearance.

I understand that Producer has been induced to proceed with the production, distribution and exploitation of my appearance in reliance of this Release, but nothing herein shall obligate me to render an appearance.

I hereby release Producer and each of its assignees, successors, officers, directors, agents, representatives, employees, sub-contractors, sponsors, shareholders, partners, members and affiliates from any and all present and future claims and demands arising out of or in connection with the uses of my appearance, including, without limitation, any and all liability arising out ofProducer’s taping and/or recording of me, my voice, image, likeness and use thereof, any and all claims for invasion of privacy, infringement of rights of publicity, defamation (including libel and slander) and any other personal or property right, includingpersonal injury. I agree that I shall not now or in the future assert or maintain any such claim against Producer and its assignees,successors, officers, directors, agents, representatives, employees, sub-contractors, sponsors, shareholders, partners, members and affiliates.

I represent and warrant that (i) I understand acknowledge and accept that my participation and appearance in the Program involves certain inherent risks, including, but not limited to, property damage and serious bodily injury (including death), and agree that my voluntarily participation in the Program is with full knowledge of the risks involved and I accept all risks of participation (ii) that I am able-bodied and possess the requisite skill level to participate in the Program, and (iii) that I shall hold Producer its assignees, successors, officers, directors, agents, representatives, employees, sub-contractors, sponsors, shareholders, partners, members and affiliates harmless from and against any claim, demand, liability or judgment, including reasonable attorneys' fees and court costs, arising out of any injuries sustained by me during my appearance. I further representand warrant that I am not a member of any collective bargaining organization, including, but not limited to, the Screen Actors Guild and the American Federation of Television and Radio Artists, and that I have the full right, power, and authority to signthis Release.

I understand, acknowledge and accept that this Release is intended to be as broad and inclusive as permitted by the laws of the state in which my appearances is taken or reproduced and agree that if any portion of this Release is invalid, the remainder willcontinue in full legal force and effect. I further agree that any legal proceedings related to this Release shall take place in Philadelphia County, Pennsylvania.
